Treasurer's Report- Matt Hutchinson Gave the treasurer's report. Matt stated that the members of the association have been very good about paying their dues, with only a few members still needing to pay. The Association has an account Balance of \$6,733.49 as of October. The expenditures for this year have been \$2,179.74. Expenses have been low because there have not been in person meetings this year due to Covid-19.

OHA Updates/New PUP Template- Emilio Debess reported there was a dead bird that tested positive for WNV early this year in Lane County. It was unexpected and Lane County conducted further surveillance. One woman tested positive recently in Multnomah County as well as a man in Columbia County. Debess stated that this was a slow year for WNV. Nationwide A discussion ensued regarding low WNV reporting and a lack of communication of WNV information in some states. There was discussion regarding surveillance in Lane County and districts willing to offer support.

There was discussion of the new Pesticide Use Plan template, and pesticide use plans are due to by March 1st 2021.

Danette Faucera is no longer in charge of Pesticide use plan for ODFW, her replacement is Ann Hayden-LesMeister.

OMVCA Updates/ New PUP Template- Matt Hutchinson informed the group that he has the new PUP template if anyone needs it just email him.

Matt suggested scheduling a call with Ann at ODFW who has replaced Danette as our PUP contact person.

N95 Mask Requirements- A discussion took place regarding N95 masks for use when applying pesticides and the requirements of performing fit tests for those masks. The SDAO and OSHA have resources available to assist you with this process.
